COMMERCIAL ACCOUNT AGREEMENT AND CONTINUING GUARANTY

for Holliday Rock Co., Inc. Hereinafter referred to as "HOLLIDAY"

_____ REFERRED TO AS THE "CUSTOMER"

Applicant

and HOLLIDAY, a California corporation agree that the following terms shall apply to the account of the CUSTOMER with HOLLIDAY.

1. HOLLIDAY is authorized to extend credit to the CUSTOMER in the form of Purchases on account.
2. The following terms shall apply to the account: Net 10th prox., The account becomes delinquent if any invoice is not paid before the end of the month following the date of purchase.
3. In the event this account becomes delinquent, the CUSTOMER and any guarantor(s) agree; a) Interest will be paid at the rate of 18% per annum from the date of delinquency on the unpaid balance until paid in full; b) This account is a commercial account; c) Any collection action necessary or other litigation concerning this account or purchases under it shall be filed in the Los Angeles, Orange, San Bernardino superior/municipal Judicial District; and d) In the event any collection action is taken to collect this account, actual attorney fees, collection agency fees and costs will be paid by the CUSTOMER.
4. Failure to meet payment terms, time being of the essence, constitutes a material breach of this agreement. Immediately upon breach, HOLLIDAY is authorized to place CUSTOMER on C.O.D. status and/or terminate sales to CUSTOMER without further notice. Credit is conditioned on applicant and guarantor continuing to meet credit terms and policies of HOLLIDAY.
5. By signature below CUSTOMER authorizes HOLLIDAY and the references contained herein to release credit history for the purpose of extending or maintaining an account with HOLLIDAY.
6. This is not an installment sales contract. I/we agree to all terms and conditions contained on all invoices and delivery tickets which are incorporated herein and made a part of this agreement.
7. CUSTOMER agrees to furnish HOLLIDAY, on request, with copies of all "Bonds", "Contracts", "Notices of Commencements", purchase order(s), job numbers, job addresses and other information HOLLIDAY deems necessary to protect HOLLIDAY'S interests. CUSTOMER agrees that HOLLIDAY may send out any necessary notices required to secure available lien and/or bond rights and provide and disclose invoices and charges to Buyer's account to obtain payment from any third party. All materials are sold "as is", based on availability, without any warranty, express or implied including the warranties of merchantability and fitness for a particular purpose. In no event shall HOLLIDAY be responsible for consequential or incidental damages of any kind including, without limitation, any expense for removal or reinstallation resulting from any defect, including and delay damages, impact damages, lost profit, labor costs, equipment and tool costs, material costs, bond and insurance costs, home office overhead costs, jobsite overhead, interest and attorney's fees and claim preparation costs.
8. CUSTOMER and guarantor(s) agree to give written notice of any change in the principals, name or legal identity of CUSTOMER 15 days prior to such change. Seller may at any time change the credit terms of this account effective on mailing a notice of the change to applicant. Guarantor(s) waive any right to notice of any modification, supplement, extension, accord and satisfaction, amendment, termination or alteration of this Agreement, and further waives any right to notice or demand upon default by CUSTOMER and further waives any notice to any renewal, compromise or change in the time for payment by CUSTOMER or the terms of any obligation by CUSTOMER to HOLLIDAY, and that HOLLIDAY may do any of the foregoing upon any such terms and at such times as HOLLIDAY, in it's discretion, deems advisable, without impairing, affecting, reducing or releasing any of the terms of the guaranty. Any change may affect amounts owed on the date the change is effective as well as amounts due for purchases made after the change.
9. CUSTOMER is familiar with and understands the need for filing the California Preliminary Notice and agrees to furnish the informatin to HOLLIDAY on all jobs.
10. CUSTOMER agrees that if credit is extended based on a faxed copy of this application it will be considered as an original.

In the event legal action is taken to enforce this Continuing Personal Guaranty, I/WE will pay all actual, collection and attorneys fees and costs.
